In the 2<sup>nd</sup> Stage, bidding documents will be issued only to the prequalified bidders to submit their bids.

#### Collection and Transportation of Solid Waste in Phnom Penh City

1. The Phnom Penh Capital Administration (PPCA) is seeking to award contracts for the Collection and Transportation of Solid Waste in Phnom Penh City (the Contract) under an international competitive bidding process. For this purpose, the Phnom Penh City will be divided into three (3) Zones and Contracts will be awarded Zone-wise. The procurement process will follow a two stage bidding procedure under which prospective bidders will be prequalified under the 1<sup>st</sup> stage. In the 2<sup>nd</sup> stage the bid documents will be issued to only prequalified bidders in Stage 1.
2. The PPCA intends to prequalify firms for the three Contracts and invites interested Applicants to submit applications for Prequalification.
3. The Invitation for Prequalification is open to all eligible national and international Applicants, including Joint Ventures and Consortiums.
4. It is expected that the Invitation for Bids will be issued in **late April 2020** to those Applicants who have met all the qualification requirements specified in the Prequalification Document.
