Invitation for Bids

CONSTRUCTION CIVIL WORK OF THE VOCATIONAL SCHOOL OF TOURISM (VST)

1. The Kingdom of Cambodia has received a loan from the AFD - Agence Française de Développement toward the cost of *The Establishment of the National Vocational Training School in the Tourism Sector*, and it intends to apply part of the proceeds of this loan to payments under the Contract No:
 - VST-W-01: Lot 1 for Construction Work of The Vocational School of Tourism in Phnom Penh
 - VST-W-02: Lot 2 for Construction Work of The Vocational School of Tourism in Sihanoukville
 2. The Ministry of Tourism of Cambodia now invites sealed bids from eligible and qualified bidders for *Construction Work of the Vocational Schools of Tourism (VST) in Phnom Penh and Sihanouk Ville*. The construction period is 15 months.
 3. Procurement will be conducted through National Competitive Bidding Procedures outlined in the Government's Standard Operating Procedures on Procurement for Externally Financed Projects/Programs.
 4. This invitation is open to all qualified bidders from eligible source countries of as described in the Bidding Document.
 5. Bidders attention is drawn to Sub-Clause 6.3 of the Instructions to Bidders (ITB) on the Qualification requirements. Qualification requirements include:
 - Average Annual Construction Turnover:
 - For Lot 1: US\$ 5,000,000.00 (Five million) for the years 2018, 2019 and 2020
 - For Lot 2: US\$ 4,400,000.00 (Four million four hundred thousand) for the years 2018, 2019 and 2020
 - Specific Similar Experience: Under construction contracts in the role of prime contractor, JV member for at least the last 5 Years, starting from 1st January 2016 to 31st December 2020:
 - For Lot 1 : experience as prime contractor in the construction of at least two (2) works of a similar nature or complexity equivalent to the works within the last five years (2016, 2017, 2018, 2019, 2020) with minimum contract price of US\$ 3,000,000 (three million);
 - For Lot 2 : experience as prime contractor in the construction of at least two (2) works of a similar nature or complexity equivalent to the works within the last five years (2016, 2017, 2018, 2019, 2020) with minimum contract price of US\$ 2,500,000 (two million five hundred thousand).
 - Liquid Assets: The Bidder shall demonstrate capacity to access to, or has available, liquid assets, unencumbered real assets, lines of credit, and other financial means (independent of any contractual advance payment) sufficient to meet the construction cash flow requirements estimated as for Phnom Penh, US\$ 700,000 (seven hundred thousand), and for Sihanouk Ville, US\$ 600,000 (six hundred thousand), for the subject contract(s) net of the Bidder's other commitments.
- Please note that for multiple lots, the criteria for qualification are aggregate minimum requirements of all the lots for which the Bidder submits a Bid.

10. All bids shall be accompanied by a Bid Securing Declaration as described in the ITB.

The Government and the AFD - Agence Française de Développement will respectively declare a firm ineligible either indefinitely or for a stated period of time, to be awarded a contract funded by them, if they at any time determine that the firm has engaged in fraud and corruption as described in ITB 3.
